President's Letter

Dear Brothers and Sisters in Christ,

A large focus of 2021 and into early 2022 was the Re:Vitality program that we participated in. This process led us through examining the core values of our congregation, and from this the creation of mission, purpose, and vision statements. Through much prayer and discussion this process led us to preparing goals that we are now using to help achieve our purpose as a congregation. Thank you to everyone who was involved in this process, and to those who have been working hard already to accomplish these goals. We have started to see the fruits of these labors, and will continue to be working through them this year.

As a congregation we recently made the decision to pursue calling a second full-time pastor. This decision has significant implications for us. It is a recognition that the harvest fields are ripe, and we realize that we need additional help in the harvest. With the expected expansion of ministries and outreach this additional support will provide, there will be a need for additional volunteers to meet these needs. We also need to be prepared for the additional financial obligation of another staff member. Please be praying that God would already be preparing this pastor for service in our congregation, and that we would be ready to accept him as a part of the team here.

We have the blessing of a wonderful facility in which we worship, teach, and fellowship with each other. However, we are reminded each year that it is not a new building, and is in need of regular maintenance. Our Trustees have been doing an admirable job of not only maintaining it, but also making marked improvements, such as the new entry doors. Our next known task is maintenance of a portion of the roof of our sanctuary. Being good stewards of all the resources we have been provided is an important task, and I thank you for all the work that is being done.

Thank you also to our staff and everyone who served our congregation in any way this past year - whether on a board, by volunteering in any capacity, through prayer, financial support, or any of the multitude of ways that make this congregation what it is. As we make important decisions this year that will impact the future of the congregation I encourage you to be a part of the process through participation in congregational meetings.

As you know, this past year we have had monthly memory verses (a wonderful idea!). Those of you who know me well know that my memory is not one of my strong points. However, our memory verse from Isaiah 55 has stuck with me. Including a few verses before the actual memory verses, it reads: "Seek the Lord while he may be found; call upon him while he is near; let the wicked forsake his way, and the unrighteous man his thoughts; let him return to the Lord, that he may have compassion on him, and to our God, for he will abundantly pardon. For my thoughts are not your thoughts, neither are your ways my ways, declares the Lord. For as the heavens are higher than the earth, so are my ways higher than your ways and my thoughts than your thoughts. "For as the rain and the snow come down from heaven and do not return there but water the earth, making it bring forth and sprout, giving seed to the sower and bread to the eater, so shall my word be that goes out from my mouth; it shall not return to me empty, but it shall accomplish that which I purpose, and shall succeed in the thing for which I sent it." 6. New Business:

- a. 2022 Annual Budget, in the packet pages 6-10 is where you will find it. Thanks to all the boards for all your work on putting this together, we are looking at an overall increase of 4.68% in the budget. Motion made and seconded to approve the proposed budget. Motion Carried.
- b. Officer and Board Elections: After announcing additional names to be placed on the ballot a motion was made and seconded to approve the ballot. Motion carried. Motion made and seconded to vote a unanimous Ballot. Motion made and seconded to approve. Motion carried. Result of the election Follow: all two-year terms, Congregational Secretary, Valerie Elliott. Treasurer, Doug Haeder. Financial Secretary, Bev Clark. Council at Large, Missy Schultz. Board of Elders. Lon Whitehead, Randy Burmeister, Tom Benson, Mike Blomquist. Board of Education, Samantha Tess, Rhonda Prince. Board of Trustees, Bob Baker. Board of Endowment, Mel Hendrickson. Board of Deacons, some two year and one year to be determined at their first meeting, Denise Painter, Lindsey Marso, Kathy Taylor, Vicky Senne, Jean Anderson.
- c. Roof Replacement Discussion: Three bids were available for review, one for repairs of the existing seams etc., and two for replacement plus upgrades, Discussion followed Motion made and seconded to return to the Trustees to discuss at their December meeting to make a recommendation and bring it to the January Voters Meeting. Motion Carried. After more discussion a Motion was made and seconded to approve starting a Fund Drive to replenish our capital improvement Budget line and be prepared to move forward on the roofing issues. Motion Carried.

- d. Electrical Work/ Insurance Concerns. President Matt Brand informed the voters of a recommendation from our Insurance Company about Electrical panels located in the building that are not UL approved, this was discussed at the November Planning Council meeting and decided we would undertake the repairs so that we would remain covered by insurance.
- e. Calling Process Procedures: The Board of Elders are recommending Calling a Graduate Student and Chairman Judd Schultz explained the process and stated a letter would be mailed out to the Congregation explaining the rational and procedures a Special voter's meeting most likely will occur in December to jump start this process.
- 7. We closed with the voters all reading aloud Psalms 46, followed with the Lord's Prayer.
- 8. President Matt Brand closed the meeting by asking that the outgoing and incoming Officers and Board members attend the December meetings to coordinate the process. Meeting adjourned at 2:03 PM.

Board of Endowment Annual Report - 2022

We thank Lon Whitehead for his service on the board. He resigned in October so he could be elected and serve as an Elder for our congregation. The newly elected member who will serve on our board is Mel Hendrickson. He will complete the remaining two years of Lon's term.

The Endowment Board's objectives are to promote and receive contributions and manage the monetary gifts and bequests. These funds are invested with the Lutheran Church Missouri Synod Foundation for long term growth and income. Currently the funds are invested as follows: 62.5% equities and 37.5% bonds. Future contributions and investment returns are allocated 90% to our general fund and 10% to our scholarship fund, unless the donor specifies otherwise. Please consider making a contribution to our Endowment Fund. You may also name Our Savior's Lutheran Church Endowment Fund as a beneficiary in your will.

As our Endowment Fund continues to grow and generate investment income, it will significantly help the mission and ministry of Our Savior's Lutheran Church now and in the years to come. Both the principal and income can be used for projects, programs, scholarships and mission activities. Endowment funds are not intended to be used for the congregation's operating budget.

This year the Board continued to provide \$3500.00 to the "Adopt-A-Student" program at Concordia Seminary in St Louis, MO. The student receiving these funds this year is Sam Hoag. He is currently doing his vicarage in Florida. He and his wife are expecting their first child in May. We provided \$3750 in scholarship money to pay 50% of the tuition cost for 3 students from our congregation who are attending Concordia Classical Academy in North Mankato. We also provided two post secondary scholarships of \$2500 each to Sarah Bjornstad and Naomi Brand. Both of these students are members of our congregation and are preparing for careers in full time church work. We continued to support Johanna Heidorn in the amount of \$2000 for her mission work with the Lutheran Church Missouri Synod.

Our board had a display at the Palm Sunday Information Fair to promote the Endowment Fund. This was a beneficial activity and we plan to participate again in 2023. Our board holds quarterly meetings at the church in January, April, July and October. A copy of our bylaws is on the church website. The September 30, 2022, treasurer's report is the most recent report available. The December 31, 2022, treasurer's report will be available the end of January.
