- 1. Meeting was called to order at 11:47 A.M. by President Matt Brand.
- 2. Opening Prayer was led by Pastor Adam Matheny
- 3. Under 9. C. add Sanctuary Art and 9.D. add New Logo and Branding. Motion made, seconded to approve the amended Agenda, motion carried.
- 4. Motion made and seconded to approve as presented the November 20, 2022 and December 11, 2002 Voter's Meeting minutes, motion carried.
- 5. Pastor's report, Pastor Adam Matheny expressed appreciation for the congregation, staff and leadership, then explained why he asks for forgiveness from the congregation.
- 6. Treasurer's report, Treasurer Doug Haeder reviewed the end of the year report, noting 2022 and 2021 were similar for expenses and he is available to answer any questions. There were no questions from the congregation.

We are pleased to provide the following proposal for the above referenced project. Please note this proposal assumes the following scope of work and the qualifications/exclusions as noted.

SCHWICKERT'S TECTA, LLC, hereinafter referred to as "Contractor", proposes to furnish and apply all labor and materials listed below with the necessary tools and equipment to complete the following project for "Our Saviors Lutheran Church" hereinafter referred to as "Owner."

Scope of Work

BASE BID:

- Remove roof membrane, metal edge and counter flashings, down to the existing insulation.
- Examine existing insulation and replace wet or contaminated at a rate of \$4.45 per square foot.
- Disconnect and move 2 HVAC units and duct work from wall. Install new wooden sleeper rails for units to be reset on. Including new sheet metal caps.
- Reclaim and remove 2 split system A/C units. Install new roof in these locations, manufacturer walk pads, and reset units on walk pads.
- Install wood blocking on the perimeter as required to accommodate the added tapered insulation, and the fastening of new perimeter edge metal.
- Provide 4 new scupper locations, that will drain into the courtyard.
- Install new 1/8" per foot tapered polyisocyanurate insulation over the entire roof. Insulation to have a minimum 1/2" start and be mechanically anchored using 1 fastener every 2 square feet.
- Install a 60mil adhered EPDM membrane roof system per manufacturer requirements, including secure strip at the perimeter, new pipe boots, pourable sealer pockets, and additional flashing membrane plies at penetrations.
- Install new fascia and cant edge metal at the perimeter and in the courtyard, new metal counter flashing at interior walls.
- Install 4 new down spouts in the courtyard, including 8-foot extensions to drain water toward the ground drain in middle of the courtyard.
- Metal to be 24. gauge pre-finished steel, chosen from manufacturers standard color palette.

Alternate 1) To install new roofs on the NW entry and the SW overhang roofs, add an additional \$7,500.00 to the contract/ Proposal price. This work to be performed if accepted with base bid.

Alternate 2) To remove membrane, install ½" HD iso insulation, and new 60mil EPDM membrane at the 2 sloped roof areas, add an additional \$29,850.00 to the contract proposal price. This work is priced to be accepted with the base bid and is not a stand alone price.
