Call Update

The Call List received from the District President included 16 names of Pastors to be reviewed. Calls were made to all 16 Pastors to determine if they would consider a Call at this time. 5 on the list declined to consider a Call for various reasons, leaving 11 names for the Call Committee to review and assess. A meeting was held April 30th to discuss the candidates. Each Committee member provided their top 5 choices, and discussion took place regarding the scoring and the individual Pastors. The results of the scoring and discussion provided 7 Pastors that the Committee would like to interview. Virtual interviews are scheduled for the period between May 13 and May 22. Interviews will be recorded so they can be viewed by Committee members that cannot attend the scheduled interview time. A Committee meeting will be scheduled for the end of May to discuss the interviews and candidates. Potential visits by top candidates will then be scheduled in June, with a Special Voters Meeting scheduled after the visits take place for the Call Committee to provide the congregation with their recommendation for a Call.
